

Terms and Conditions of BEA Credit Card Contactless Parking and Auto Payment Parking Offer at SHKP Malls (refers to "Parking Offer Promotion"):

- 1. The Parking Offer Promotion is valid from 1 March to 31 May 2024, both dates inclusive (a total of 92 days, refers to "Promotional Period").
- 2. The designated shopping malls providing Contactless Parking and Auto Payment Parking service under Sun Hung Kai Real Estate Agency Limited (refers to "SHK Real") participating in the Parking Offer Promotion include Kwun Tong apm, Tuen Mun Chelsea Heights (car park at Phase II), Tseung Kwan O East Point City, North Point Harbour North (car parks at Phase 2 & 3), Sha Tin HomeSquare, Sheung Shui Landmark North, Kwai Fong Metroplaza, Sheung Shui Metropolis Plaza, San Po Kong Mikiki, Mongkok MOKO, Sha Tin New Town Plaza, Tseung Kwan O Park Central, Tseung Kwan O PopWalk (car parks at PopWalk 2, 3 & Ocean PopWalk), Tai Po Mega Mall (multi-storey car park), Tsuen Wan Plaza, Tai Po Uptown Plaza, Tuen Mun V city, Nam Cheong V Walk, Causeway Bay wwwtc mall, Yuen Long YOHO MALL and Yuen Long Plaza (refers to "CP Participating Malls").

The Parking Offer Promotion applies to Cardholders who hold an eligible BEA Visa or Mastercard Credit Card (refers to "Eligible Credit Card" / "Cardholders"), excluding a corporate card, JCB PLATINUM Card and UnionPay Dual Currency Credit Card, issued by The Bank of East Asia, Limited (refers to "BEA").
- 4. Cardholders must be existing The Point member who completed the registration of Contactless Parking and activated Auto Payment Parking Service through The Point App to participate in the Parking Offer Promotion (refers to "Eligible Customers").
- 5. Eligible Customers who bind and authorize the Eligible Credit Card as the default card for automatic fee settlement of Contactless Parking & Auto Payment Service in The Point App, and use the Eligible Credit Card to settle the parking fee of CP Participating Malls through The Point App during the Promotional Period, are entitled to receive the following point rewards (refers to "Parking Rewards"):
 - Parking Reward 1: Receive \$20 Point Dollar (equivalent to 5,000 The Point bonus points) upon the first time settlement of parking fee.
 - Parking Reward 2: Receive \$10 Point Dollar (equivalent to 2,500 The Point bonus points, refers to "Parking Reward 2") upon each subsequent settlement of parking fee.
- 6. Each parking fee settlement must be in single net amount of HK\$15 or above to be eligible to receive Parking Reward.

For example, Member A binds four different Eligible Credit Cards in The Point App and settles parking fees with each Eligible Credit Card once, member A is entitled to receive \$50 Point Dollar in total (i.e. Parking Reward 1 once and Parking Reward 2 three times); Member B and Member C each binds the same Eligible Credit Card in The Point App and settle parking fees once respectively, each of them is entitled to receive \$20 Point Dollar (i.e. Parking Reward 1 once for each).
- 10. Each Eligible Customer can register up to three vehicle plate numbers under the same The Point member account, but the eligibility to receive rewards will be calculated together. For example, a member settles parking fee for each of the three registered vehicle plate numbers using the same/different Eligible Credit Cards in The Point App, is entitled to receive \$40 Point Dollar in total (i.e., Parking Reward 1 once and Parking Reward 2 twice).
- 11. Each vehicle plate number can only be registered by one The Point member for Contactless Parking

- through The Point App.
- 12. The Point Dollar Rewards earned during 1 March to 30 April, 2024 will be credited to the Eligible Cardholder's The Point member account on or before 30 June 2024; The Point Dollar Rewards earned during 1 May to 31 May, 2024 will be credited to the Eligible Cardholder's The Point member account on or before 31 July, 2024. The credited bonus points will expire on 30 September, 2025. The expiry date of the bonus points credited will be 30 September 2025. Each \$1 Point Dollar can be used as HK\$1 when spending at applicable merchants at 25 SHKP Malls. In the event that the outstanding parking fee cannot be settled using the default Eligible Credit Card due to various issues, including but not limited to credit card system malfunctions, the system will send a "Parking Payment Reminder" to customers through in-app messages. Parking fee must be settled at car park exit via the barrier machine and those transactions are not eligible to enjoy the Parking Offer Promotion.
- 16. All eligible transactions must be completed within the Promotional Period, and posted to the relevant card accounts on or before 14 June 2024.
- 17. All transactions made during the Promotional Period that are found to be fraudulent or eventually cancelled / returned on or before 31 May 2024 will be considered as ineligible transactions and are not applicable to the Parking Offer Promotion.
- 18. Net spending refers to the final amount charged to the Eligible Cards. The use of other discounts / offers will not be taken into account when calculating net spending.
- 19. The Parking Offer Promotion is subject to the terms and conditions of "Contactless Parking and Auto Payment Parking Service". For details, please refer to The Point App, corresponding promotional materials or contact malls' Customer Care Centre.
