Terms and Conditions for HSBC Visa Signature Card Privileges – Contactless Parking and EV Super Charging Rewards at SHKP Malls

When can you enjoy the offer

1. The promotional period for the offer is from 1 July 2026 to 13 September 2026 (or while stocks last) ("Promotional Period").

What is the offer

2. Cardholders of HSBC Visa Signature Card with card no. beginning with 496604 ("Visa Signature Card") must be existing The Point members and have completed the registration for Contactless Parking via The Point mobile application ("The Point App"). Cardholders must also either bind and set their Visa Signature Card as the default credit card for the first time, or have not used the bound Visa Signature Card to settle hourly parking fees or EV Super Charging fees via The Point App between 1 January 2026 and 30 June 2026. During the Promotional Period, cardholders who settle any hourly parking fees or EV Super Charging fees in net amount of HK\$70 at **Participating Malls** via The Point App using this card will be entitled to the following privileges:

Privilege 1 — Contactless Parking Reward

During the Promotional Period, each eligible member (based on The Point member ID) who settles hourly parking fees via The Point App using a Visa Signature Card for the first time will receive 5,000 The Point bonus points. Member will receive 2,500 The Point bonus points for each of the second and third hourly parking fee transactions, up to a maximum of 10,000 The Point bonus points in total.

Privilege 2 — EV Super Charging Reward

During the Promotional Period, each eligible member (based on The Point member ID) who spends a net amount of HK\$70 or above on EV Super Charging service via The Point App using a Visa Signature Card for the first time will receive 5,000 The Point bonus points. Members will receive 2,500 The Point bonus points for each of the second and third eligible transactions, up to a maximum of 10,000 The Point bonus points in total.

- 2.1. Throughout the entire Promotional Period, a total quota of 10,000 is allocated for the first time of Contactless Parking/ EV Super Charging reward, and a total quota of 10,000 is allocated for the second and third time of Contactless Parking/ EV Super Charging rewards across all designated Participating Malls. Quotas are

available on a first-come, first-served basis, while stocks last. The promotion will terminate immediately once the quotas are fully redeemed without prior notice.

2.2. The Point bonus points earned will be credited to the member's account on or before 30 September 2026. You can refer to the "Point History" in The Point App for details. The expiry date of the bonus points received will be 30 September 2027. The Point bonus points can be converted into Point Dollar for use as cash for spending, free parking, or free EV Super Charging services. How can you enjoy the offer

3. You can enjoy the offer if you:
 - a. hold an Eligible Credit Card and your credit card account is valid and in good standing during the promotional period and the offer fulfilment period;
 - b. are an existing The Point member or have successfully registered as a The Point member; and
 - c. Bind and set your Visa Signature Card as the default card for the first time during the Promotional Period, or have not used the bound Visa Signature Card to settle hourly parking fees or EV Super Charging fees via The Point App between 1 January 2026 and 30 June 2026.

Read before you enjoy the offer

4. Before paying parking or charging fees, you must have completed the registration for Contactless Parking via The Point App, and have bound and set your Visa Signature Card as the default credit card.
5. Each vehicle plate number can only be registered by one The Point member for Contactless Parking through The Point App.
6. The promotion is only applicable to designated car parks in Participating Malls and is not applicable to residential visitor (hourly rental) car parks.
7. Transactions made at car park exit via the barrier machine or via WeChat Pay HK in The Point App will not be accepted.
8. In the event that the outstanding parking fee cannot be settled using the default Visa Signature Card due to various issues, including but not limited to credit card system

malfunctions, the system will send a "Parking Payment Reminder" to customers through in-app messages. Parking fee must be settled at car park exit via the barrier machine and those transactions are not eligible to enjoy the promotion.

9. All transactions made during the Promotional Period that are found to be fraudulent or eventually cancelled / returned on or before 13 Sep 2026 will be considered as ineligible transactions and are not applicable to the promotion.
10. Each participating mall has different mechanisms for redeeming free parking hours or free EV charging sessions with points. For details, please refer to the relevant page on The Point App.
11. The promotion is subject to the terms and conditions of "Contactless Parking and Auto Payment Parking Service" and "The Electric Vehicle (EV) Super Charging service". For details, please refer to The Point App, corresponding promotional materials or contact malls' Customer Care Centre.

21. **‘Participating Malls’** means the designated malls with Contactless Parking/ EV Super Charging service under SHK Real.
