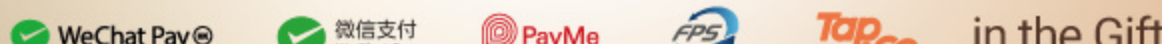

### Terms and Conditions of "SHKP Malls Gift Card Mobile Payment Extra Rewards Program"

1. "SHKP Malls Gift Card Mobile Payment Extra Rewards Program" (refers to "Program") runs from 2 Jul to 31 December 2025 or until all the Point Rewards are depleted (refers to "Promotion Period").
2. The Program is only applicable to members of The Point Integrated Loyalty Program (refers to "Member").
3. The Program is only applicable to the participating malls with SHKP Malls Gift Card sales counter under Sun Hung Kai Real Estate Agency Limited (refers to "SHK Real"), including apm (Kwun Tong), East Point City (Tseung Kwan O), Harbour North (North Point), Landmark North (Sheung Shui), New Town Plaza (Sha Tin), Tai Po Mega Mall (Tai Po), V city (Tuen Mun) and YOHO MALL (Yuen Long) (refers to "Participating Malls").
4. Members are entitled to redeem the equivalent value of The Point bonus points (refers to "Point Reward") upon any single purchase of SHKP Malls Gift Card(s) (refer to "Gift Card") with total value of HK\$3,000 or above (regardless of the Gift Card denomination and quantity) with Alipay (applicable to Hong Kong and China Wallet), BoC Pay, FPS, PayMe, Tap & Go, UnionPay QR Code Payment (including but not limited to UnionPay APP or other mobile applications supporting UnionPay QR Code payment) or WeChat Pay (applicable to Hong Kong and China Wallet) (refers to "Designated Mobile Payments") at the Gift Card sales counter in the Participating Malls during the Promotion Period or before all the Point Rewards are depleted. If a member purchases 3pcs of HK\$1,000 Gift Card at one time, the member will be rewarded with 3,000 bonus points; or if a member purchases a \$8,000 Gift Card at one time, the member will be rewarded with 8,000 bonus points, and so on.
5. Payments other than the above Designated Mobile Payments, and the use of The Point bonus points, Point Dollar and other means of redemption are not accepted to purchase the Gift Card for participating in the Program.
6. Members must purchase the Gift Cards at the SHKP Malls Gift Card sales counters in the Participating Malls in person and must not authorize a third party to do so. Customers themselves must be the relevant The Point member. Staff of the Participating Malls reserves the right to request the purchaser to provide identification documents for verification purposes.
7. Each Member (based on The Point member ID) can only redeem a maximum of total 25,000 bonus points in all Participating Malls during the entire Promotion Period.
8. During the entire Promotion Period, the Point Rewards available for distribution in all Participating Malls are 15,000,000 The Point bonus points. Limited quota and available on a first-come-first-served basis, while stocks last.

13. The Gift Card cannot be cancelled, altered, redeemed, returned and refunded or exchanged for cash, other product(s) or service under any conditions once they are sold. If the Gift Card is lost, damaged or stolen, SHK Real and Participating Malls shall not be responsible for these incidents.
14. The Gift Card is valid for 12 months from the date of purchase. The expiry date is printed on the card back as VALID THRU "MONTH / YEAR". Purchase and use of the Gift Card is bound by related terms and conditions. 16. By participating in the Program, the Member accepts and agrees to abide by all relevant terms and conditions.
17. In case of any fraud or abuse, SHK Real and Participating Malls reserve the right to disqualify the Members and retrieve the Point Reward from the Members after disqualification.
18. Mobile Payment/Electronic Payment Applications are third-party Mobile Applications. The terms of use of the application are subject to the relevant terms and conditions of the provider. SHK Real and the Participating Malls are not the providers of the Mobile Payment Applications.
